PROPOSAL 14-1

APPROVAL OR DISAPPROVAL OF AMENDATORY ACT TO REDUCE STATE USE TAX AND REPLACE WITH A LOCAL COMMUNITY STABILIZATION SHARE TO MODERNIZE THE TAX SYSTEM TO HELP SMALL BUSINESSES GROW AND CREATE JOBS

The amendatory act adopted by the Legislature would:

1. Reduce the state use tax and replace with a local community stabilization share of the tax for the purpose of modernizing the tax system to help small businesses grow and create jobs in Michigan.
2. Require Local Community Stabilization Authority to provide revenue to local governments dedicated for local purposes, including police safety, fire protection, and ambulance emergency services.
3. Increase portion of state use tax dedicated for aid to local school districts.
4. Prohibit Authority from increasing taxes.
5. Prohibit total use tax rate from exceeding existing constitutional 6% limitation.

SERVICES TO OLDER CITIZENS MILLAGE RENEWAL AND INCREASE PROPOSAL

"Shall the previously voted increase in the limitation on the total amount of general ad valorem taxes which may be imposed for all purposes upon real and personal property in Midland County to benefit older citizens, which last resulted in a levy of up to 0.75 Mill (\$0.75 per \$1000.00) of taxable valuation, be renewed and increased for a levy up to 0.90 Mill (\$0.90 per \$1000.00) of taxable valuation, as finally equalized in the years 2014 through 2017, both inclusive, as authorized in Article 9, § 6 of the Michigan Constitution of 1963, as amended, for the purpose of continuing services to older citizens (60 years and older) in Midland County through the Council on Aging, an agency authorized by 1976 PA 39, which if approved and levied in its entirety is estimated to raise \$3,280,644 in the first year?"
